The rate applicable for Pavilions occupying space of 401 sq.mtrs and more, will be that of 101 & above square meters slab only.

Important Note:-

- All participants must remit 50% advance payment in lieu of their confirmation of participation within 30 days from the date of invoice.
- In an extraordinary circumstance of postponement of the event to 2022, then the amount paid towards the participation in Excon 2021 will be carried forward (without levying of any charges) to the postponed date when the event will be organised.
- In case a company decides to cancel the stall booked, amount will be withheld in line with the cancellation policy which will be based on the period in which the said participation is cancelled. In addition the company will also lose 25% of the points accumulated over the years to arrive at their seniority in Booking Sponsorship / Space. There will no relaxation on this point.
- In case a company books space and then would like to reduce space at a later date, CII reserves the right to reallocate the company to another location available in the exhibition where the reduced space is available.
- The Stall / Space Rentals are excluding of Electricity Charges (built-up stalls package includes only single phase connection).
- All companies have to provide correct GST number and address matching to the GST number to Raise Tax Invoice. Goods and Service Tax is extra on Stall / Space Rentals and Electricity Charges as per the Government of India Notification.
- MSME: Exhibitor whose stall area is less than 12 Square Meters and is an MSME registered company is eligible for preferential tariff which is published in the above space rentals chart (the preferential tariff is 20% off on standard pricing). The MSME preferential tariff is applicable for Indian companies only. The MSME certificate should be submitted for availing the benefit. This is inline with CII's policy on enabling MSME's.
